Notice on Change of the Accounting Auditor

Ahresty Corporation ("the Company") resolved at the meeting of its Audit and Supervisory Committee held on June 1, 2022 to change its accounting auditor who performs audit certification set forth in Article 193-2, paragraphs (1) and (2) of the Financial Instruments and Exchange Act, and it also resolved at its Board of Directors' meeting held on the same day to submit the matter as a proposal on election of the accounting auditor at the 101st annual shareholders' meeting scheduled to be held on June 28, 2022. The Company's Audit and Supervisory Committee designated Grant Thornton Taiyo LLC as the candidate for its accounting auditor because by appointing the said audit firm, the Company can expect audits from new perspectives suitable for the business condition of the Company. In addition to this, as a result of comprehensive consideration of its quality management system, independence, professional expertise, audit system, and level of audit compensation, etc., the firm was judged appropriate as the accounting auditor

of the Company.

6. Reason and circumstances that led to the decision of the change

The term of Deloitte Touche Tohmatsu LLC, the current accounting auditor of the Company, will expire at the closing of the 101st annual shareholders' meeting scheduled to be held on June 28, 2022. In addition to the fact that the audit duration of the current accounting auditor has reached 15 years, which is quite long, the audit compensation has been on an increasing trend due to the recent increase in audit man-hours. In view of such circumstances and as a result of comparing and examining several audit firms, the Company decided to appoint Grant Thornton Taiyo LLC as its new accounting auditor for the reason presented in paragraph 3 above.
